Severe Condition (Red) A Severe Condition reflects a severe risk of terrorist attacks. Under most circumstances, the Protective Measures for a Severe Condition are not intended to be sustained for substantial periods of time. In addition to the Protective Measures in the previous Threat Conditions (*level*), Federal departments and agencies also should consider the following general measures in addition to the agency-specific Protective Measures that they will develop and implement:

- Increasing or redirecting personnel to address critical emergency needs;
- Assigning emergency response personnel and pre-positioning and mobilizing specially trained teams or resources;
- Monitoring, redirecting, or constraining transportation systems; and
- Closing public and government facilities.

To put this into practical language for schools, these are the actions Schools should consider:

- 1. CLOSE THE SCHOOL:** If school is in session, continue the day with increased caution and make plans to close the following day. An unexpected early closing causes chaos in the community and the school in less troubling times. If the radio and television are warning "Condition Red," an early closing could create panic and paranoia. Schools are lucrative terrorist targets because of the concentration of vulnerable students. Remove that concentration and the school ceases to be such a target. If the school remains open, consider the following.
- 2. OPEN SCHOOLS:**
 - A. Contact your** local Law Enforcement agency &/or *Homeland Security State Appointee* - <http://www.whitehouse.gov/homeland/contactmap.html>. Determine if your location is perceived to be at the same level or if your Appointee believes you are at a lower level. Then act accordingly.
 - B. Alert your Emergency/Crisis Response Team** to be vigilant and quickly review emergency actions for lock-downs and evacuation.
 - C. Set up a remote-receiving site.** Redirect all incoming traffic, i.e., people, deliveries, mail, utilities, etc., to a location away from all students. Only required staff and students should be allowed in the schools and they should be required to curtail all coming and going. Designated personnel at the remote site should receive all visitors and deliveries. Non-essential mail and packages should be held in storage, visitors turned away (gracefully), rope off parking near facility and a well-trained person should be present to handle the media who will come.
 - D. Bring in additional people.** Additional "*substitute teachers*" who have been trained in your emergency procedures and who have the ability to react with discipline in an emergency could augment your staff for a day or two. Ask law enforcement to provide additional patrols around or in your schools. If your school contracts security, contact your security company for additional people. Be very careful in this regard that your security company fully checks the backgrounds of all their staff including temporary hires.



- E. Alert the Director of Transportation.** Make sure that the maximum numbers of buses are available, even if some must be pulled out of routine maintenance. Inspect all buses to insure that there has been no tampering. Pay close attention to fuel tanks and electrical systems. Provide increased security of buses during non-school hours. Be sure that your [Emergency/Crisis Response Plan](#) has evacuation procedures that include routes and alternate secondary locations. [Bus Driver Training on Terrorism](#)
- F. Conduct a passive inspection** of your facilities daily. Maintenance and custodial personnel are very familiar with how things should look; use them to walk through and around each building looking for anything out of place. Teachers should observe their classrooms with the same familiarity. **DO NOT INVESTIGATE** anything that is considered out of place. Notify law enforcement and allow them to take that step. **Note:** if a [School Site Safety Survey](#) has not been conducted act today...this will reveal areas of concern and vulnerabilities.
- G. Notify Food Service** that conditions could result in a lock-down or evacuation to alternate site. Having snack foods on hand that could be delivered to rooms or to an alternate site could make the difference in how well students handle the situation. Schools maybe required to maintain students and should have two days supply of food and water on-hand. Inform workers to halt ALL receiving of Food Products. All Food Service products and Vending Machine products should be inspected for tampering or turned off.
- H. Review your Emergency/Crisis Plans** to insure that Homeland Security measures are considered and incorporated as needed.
- I. Conduct an "After Action Review"** at each level once the danger has passed to identify any weaknesses or improvements needed.
